

Activate partnerships which will expand learning beyond the classroom and which will connect the community to the classroom.








### SUSPENSION DATA OVERVIEW

Buffalo Public Schools, Suspensions Over Time (2018-present)




#### **Short-Term Suspensions 2021-2022**




#### Long-Term Suspensions 2021-2022

### DISTRICT SUPPORT

- District-Wide Restorative Practice Training
- Each of the (4) coaches from the Office of School Climate is assigned a school. The following are some of the coaching supports offered:
  - o professional development, modeling and shadowing restorative conferencing and circles, grade level/department meetings, and wellness teams and events
- Multitiered Systems of Support (MTSS)- full day Saturday trainings have been conducted this year for school leadership teams in the areas of positive behavior supports and School Wellness Teams.
- Social Emotional Learning Curriculum- Second Step
- Social Emotional Learning Scale (SEL) is piloted at (8) schools
- Attendance Teachers work within a school's team and focus on Tier 3 interventions
- A member of the district's Crisis Team conducts lethality assessments and support schools if they have questions regarding the administration of lethality assessments
- CLRI, MBK, Big Sister Little Sister, supports through Office of Shared Accountability with Data Dashboard and other supports
- Community Partners: Partnership with Erie County Restorative Justice Coalition supports identified schools with Restorative Practices
- Community Partners: Say Yes Mental Health Clinics, School Based Clinics, Community Solutions Foundation, Back 2 Basics, Project Lee, and Parent Congress





### SUMMARY

- o Positive district—wide trends for both attendance and suspension data.
  - These gains are despite the growing body of evidence that suggests the persistent and pervasive impact of COVID-19 on Black and Brown students and economically disadvantaged schoolchildren across the country.
- Research indicates that the continued work to increase attendance and decrease suspensions will be most effective if mental health and wellness supports are robust and ongoing.
